RPIRG Board of Directors - Position Description

The Board:

The RPIRG Board of Directors is composed of 8 U of R students, and is the decision-making body of RPIRG. The Board makes all major decisions regarding the finances, goals, projects and events, staffing, and funding for the organization.

Responsibilities & Expectations:

Board members are elected in March, and their term runs from the beginning of May to the end of April the following year.

RPIRG Board Members put in an average of 7-10 volunteer hours per month from September-April, and about 3-5 per month from May-August. These hours are comprised of:

- 1. One Two board meetings per month (about 2 4 hours, including May-August)
- 2. Two committee meetings per month (about 2-3 hours combined; about 1-2 hours May-August)
- 3. Helping to run RPIRG events and promote the organization (variable, average of 3 hours per month)

Board Members are expected to attend as many RPIRG events and promotional opportunities as their class and work schedules will allow. Board Members are also ambassadors for the organization and are asked to promote the organization and its events through their networks.

All RPIRG Board Members will sit on two of our committees. These committees include Applications Assessment, Events & Marketing, Finance, Policy, and Staff Relations. Board Members will have the opportunity to choose committees which highlight their strengths and challenge them to learn new skills.

Elections:

Every spring, students vote for their Board of Directors in conjunction with other student group elections. All U of R students who have not opted-out will be able to run for a seat on the RPIRG Board of Directors. You do not have to have experience on a board in order to run! All that's required is a belief that a better world is possible and motivation to be a leader.

Benefits:

Being on the RPIRG Board of Directors has its perks! Networking with other like-minded people on the U of R campus; becoming a change-maker for social and environmental justice; gaining experience in your areas of interest through committee involvement; building your experience as a community leader; and accessing training opportunities and funds to help you gain the skills you need to be an effective global citizen!
