#### 2. Registered office:

The place of the registered office of the Corporation shall be in the City of Regina, in the Province of Saskatchewan

### 3. The classes of membership:

There shall be two classes of membership: Student Member and Associate Member. A Student Member is any registered student at the University of Regina, including its federated colleges, who pays a membership fee to the Corporation. Additionally, students from the University of Regina's satellite campuses shall also be considered Student Members, even though there is no current mechanism to collect a levy fee from them. An Associate Member is any individual who is not a Student Member but completes the appropriate application and pays an associate membership fee to the Corporation. While all classes of members shall have access to the programs and services of the Corporation, only Student Members shall have voting privileges at General Meetings and in Elections of the Corporation.

# 4. Right, if any, to transfer membership interest:

There shall be no right to transfer membership interest.

## 5. Number (or minimum and maximum number) of directors:

There shall be a minimum of three (3) and a maximum of eight (8) Directors.

#### 6. The corporation is:

# 7. Restrictions, if any, on activities the corporation may carry on or on powers the corporation may exercise:

The Corporation must be nonpartisan in all its activities.

# 8. Persons to whom remaining property is to be distributed in the course of liquidation and dissolution of the corporation:

Upon the dissolution of the Corporation and the payment of all its debts and liabilities, any remaining property shall be held in trust by an entity designated by the Board of Directors, for the purpose of establishing a similar organization that serves the University of Regina. In the event that a similar organization is not established within five (5) years of the dissolution, the trustee shall be authorized to transfer the remaining funds and assets of the Corporation to the Board of Governors of the University of Regina, to be used for the establishment and maintenance of a scholarship or bursary fund benefiting students studying at the University of Regina or any of its federated colleges. Criteria for awarding such scholarships and bursaries shall be determined by the Board of Directors of the Corporation at the time of dissolution and communicated to the trusted entity in a legal agreement.

#### 9. Other provisions, if any:

The purpose of the Corporation is to operate as a student-funded, student directed research, education and action organization pursuing the interests of students at the University of Regina and members of the wider community of Regina and beyond on issues of public concern. Specifically, the Corporation shall:

- promote and conduct research on issues of public interest and concern;
- aid in the education of Corporation members and the public at large about issues of public interest and concerns;
- promote and undertake appropriate citizen actions;
- act as a democratic organization by facilitating student participation in public interest research and aiding students in developing effective citizenship skills; and
- support the development of and the co-operation with other Public Interest Research Groups as the occasion arises.
